**A RESOLUTION TO APPROVE RAFFLE LICENSE RA 2024-1 FOR THE  
PARENT TEACHER STUDENT CONNECTION (NORTHERN BURLINGTON)  
(Legalized Games of Chance Control Commission Registration #282-5-41822)**

**WHEREAS**, the Northern Burlington Stagehounds submitted an application on March 18, 2024 for an on-premises draw raffle awarding prizes to be held on May 4, 2024 at Northern Burlington County Regional Middle School; and

**WHEREAS**, one copy of the application will be filed with the Mansfield Township police department; and

**WHEREAS**, N.J.A.C. 13:47-4.1 requires seven (7) days to elapse before the Governing Body makes its findings and determinations; and

**WHEREAS**, the required waiting period was satisfied on March 25, 2024; and

**WHEREAS**, the Northern Burlington Stagehounds, in accordance with N.J.A.C. 13:47-3 et. seq, will submit the required fee to the Legalized Games of Chance Control Commission if the raffle prizes awarded exceed \$400; and

**WHEREAS**, the Northern Burlington Stagehounds has submitted the \$20 required fee to the Township of Mansfield; and

**WHEREAS**, the Northern Burlington Stagehounds has submitted a valid Legalized Games of Chance Control Commission (LGCCC) registration form and number.

**NOW, THEREFORE, BE IT RESOLVED** by the Committee of the Township of Mansfield in the County of Burlington, State of New Jersey that Raffle License RA 2024-1 for the Parent Teacher Student Connection (Northern Burlington) to conduct an on-premises draw raffle awarding prizes on May 4, 2024 be approved effective April 3, 2024, following the expiration of the seven (7) day waiting period and submission of the required Governing Body's Findings and Determinations to the LGCCC according to N.J.A.C. 13:47-1.1; and

**BE IT FURTHER RESOLVED** that the Municipal Clerk forward the required Findings and Determinations to the LGCCC according to N.J.A.C. 13:47-1.1.


