Township of Mansfield Joint Land Use Board Meeting September 25, 2023

The regular meeting of the Joint Land Use Board was held on the above shown date with the following in attendance: Vice-Chairperson, Colleen Herbert, Douglas Borgstrom, Jeffrey Grouser, Deputy Mayor Sisz, Frank Pinto, Ralph Wainwright, Carl Schwartz, Joseph Broski, Rudy Ocello, and Maureen Villegas. Chairman Scott Preidel was not in attendance. Professionals in attendance were Attorney Patrick Varga and Planner, Ed Fox, Planner. Also in attendance were Land Use Coordinator Ashley Jolly and Secretary Linda Semus. The following Opening Statement read by Secretary Semus.

Matt Johnson, representing Burlington County as the County's Open Space Coordinator, was sworn in. His qualifications were accepted by the Board.

Mr. Johnson said he was in attendance representing Burlington County requesting a minor subdivision approval for Block 28, Lot 47.01. Burlington County is the contract purchaser of this property for a proposed 3.43-acre open space lot in fee and a farmland preservation easement on the remainder lot. He referred to a map showing the area around the village of Columbus marked as A-1. An area as marked is a segment of the County's Kinkora Trail that was constructed several years. This 3-mile trail connects from Island Road through County owned property to Mansfield's Community Park. In regard to the 3.43-acre property, they propose to make connection to Atlantic Avenue with the intent to extend the Kinkora trail north to the Delaware River and connect outside of the village of Hedding to the County's Delaware River Heritage Trail. In referring to the survey submitted as part of the application, he explained the 3.43-acre lot, which is proposed to be lot 47.04.

Planner Ed Fox had no further comments. Mr. Noll said he reviewed the plan and had no comments.

The meeting was opened to the public. With no comments or questions, this portion of the meeting was closed.
