# TOWNSHIP OF MANSFIELD BURLINGTON COUNTY REGULAR MEETING MINUTES December 16, 2020 7:00 PM

The Regular Meeting of the Mansfield Township Committee was held on the above mentioned date with the following in attendance: Mayor DiGiuseppe, Deputy Mayor Cain, Committeeman Higgins, Committeeman Magee, and Committeeman Ocello. Also present is Solicitor Timothy Prime, Engineer Johnson, Administrator Michael Fitzpatrick, CFO Grouser, Clerk Semus and Deputy Clerk Ashley Jolly.

**Clerk Semus** called the meeting to order at 7:00 PM and made the following statement: This meeting is being conducted during the current National Emergency with remote participation in accordance with guidance provided by the New Jersey Division of Local Government Services, Department of Community Affairs, as set forth in the Public Notice of this meeting.

Following the above statement **Clerk Semus** then read the following Open Public Meetings Statement to be followed by the Flag Salute:

Public notice of this meeting pursuant to the Open Public Meetings Act NJSA 10:4-6 to 10:4-21 has been satisfied. Notice of this meeting was properly given via Resolution 2020-1-8, which was adopted by the Mansfield Township Committee on January 6, 2020. Said Resolution was transmitted to the Burlington County Times and the Trenton Times, filed with the Clerk of the Township of Mansfield, posted on the official bulletin board at the Municipal Complex, posted on the official website, filed with the members of this body and mailed to each person who has prepaid any charge fixed for such service. All of the mailing, posting, and filing having been accomplished as of January 10, 2020.

# **ENGINEERS REPORT:**

# FY' 2021 CDBG Grant

**Engineer Johnson** explained that he had worked with the Clerk's office as well as, Public Works in submitting the FY 2021 CDBG Grant. The application was sent to the county through email and a hard copy is being overnighted.

# FY 2020 CDBG Grant

**Engineer Johnson** stated he is working with G&G Landscaping in regards to the ADA walkways in the Community Park. He is anticipating they will be pouring concrete early next week.

# **Stormwater Outfall Mapping**

The storm water outfall mapping that is required, will be submitted to the NJDEP by December 21<sup>st.</sup>

# **NJDOT Projects**

Both resurfacing projects on White Pine Road and Railroad Avenue are substantially complete. A separate vendor will be performing pavement, coring and testing on the asphalt that is required.

# Margolis Warehouse

Phase 2 may be looking to start construction sometime in January.

# **Mansfield Realty North**

They will be starting stormwater and site work in the coming weeks.

Administrator Fitzpatrick added that he has been getting positive feedback for both Railroad Avenue and White Pine Road.

Engineer Johnson thanked the contractors for doing a good job on the roadways.

# RESOLUTION CERTIFYING THAT ALL MEMBERS OF THE GOVERNING BODY OF MANSFIELD TOWNSHIP, BURLINGTON COUNTY, HAVE REVIEWED, AS A MINIMUM, THE SECTIONS OF THE 2019 ANNUAL AUDIT ENTITLED "GENERAL COMMENTS AND RECOMMENDATIONS"

**WHEREAS**, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

**WHEREAS**, the Annual Report of Audit for the year 2019 has been filed by a Registered Municipal Accountant with the Township Clerk as per the requirements of N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

**WHEREAS**, the Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34; and

**WHEREAS**, the Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled:

General Comments Recommendations

**WHEREAS**, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the annual audit entitled:

General Comments Recommendations

as evidenced by the group affidavit form of the governing body; and

**WHEREAS**, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

**WHEREAS**, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

**WHEREAS**, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52-27BB-52 - "A local officer or member of a local governing body, who, after a date fixed for compliance, fails or refuses to obey an order of the Director of Local Government Services, under the provision of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

**CFO Grouser** explained that the resolution is certifying that the Township Committee has reviewed at a minimum the General Comments and Recommendations portion of the audit. The affidavit will be signed by the governing body and is forwarded to the DLGS.

### TOWNSHIP OF MANSFIELD BURLINGTON COUNTY RESOLUTION 2020-12-2 RESOLUTION OF THE TOWNSHIP OF MANSFIELD, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, APPROVING A CORRECTIVE ACTION PLAN FOR THE 2019 AUDIT

WHEREAS, the Township of Mansfield, County of Burlington, State of New Jersey received its 2019 Audit, dated November 19, 2020, and submitted to the Township for review on December 16, 2020; and WHEREAS, the Township will implement the 2019 Corrective Action Plan for the findings therein as

follows:

## CORRECTIVE ACTION PLAN - 2019 AUDIT TOWNSHIP OF MANSFIELD BURLINGTON COUNTY

**Recommendation Number 2019-001** - During the audit it was noted that the Township expended certain Trust Funds without an approved Dedication by Rider from the State of New Jersey, Division of Local Government Services. \$194,890.00 in Police Outside Employment Trust Funds were expended without a 2019 Budget Appropriation or approved Dedication by Rider.

**Corrective Action:** The Township submit a request for a Dedication by Rider for Police Outside Employment to the State of New Jersey, Division of Local Government Services. This finding has been resolved by adoption of Resolution 2020-11-2 with same having been forwarded to the State of New Jersey, Division of Local Government Services requesting permission for the Dedication by Rider for the Township of Mansfield Outside Employment of Off-Duty Municipal Police Officers Trust Fund Required by LFN 2000-14.

**Recommendation Number 2019-002** – During the audit it was noted that the Township provided contributions to a duly incorporated Emergency Medical Service (EMS) Company but did not follow certain requirements of N.J.S.A. 40:5-2. During the calendar year 2019, the Township disbursed \$200,000.00 to the EMS Company; however, the Township did not perform the following requirements in connection with N.J.S.A. 40:5-2:

- a) Obtain a request from the EMS Company that additional funds are needed because it is experiencing extraordinary need directly related to the performance of the EMS Company's duties;
- b) Obtain an audit from the EMS Company resulting from contributions exceeding \$70,000.00;

c) Control the disbursement of funds in excess of \$105,000.00 (\$70,000.00 + \$35,000.00) to determine that first aid, ambulance, rescue or other emergency vehicles, equipment, supplies and materials for use by this EMS Squad were placed in the Township's name and for these uses.

<u>Corrective Action</u>: The Township follow the requirements of N.J.S.A. 40:5-2 with respect to contributions to the Emergency Medical Service Company.

**NOW, THEREFORE, BE IT RESOLVED,** that the Township Committee of the Township of Mansfield, implement the Corrective Action Plan as outlined above by the Chief Financial Officer; and

**BE IT FURTHER RESOLVED,** that the Township Clerk of the Township of Mansfield, be directed to forward certified copies of this resolution to the New Jersey Division of Local Government Affairs, in compliance with State statute.

**CFO Grouser** explained that the above resolution identifies the recommendations referenced in the previous resolution. Recommendations are also called findings and findings are areas of noncompliance that were noted by the auditors. There were two findings in the audit. The first finding was that the Township had expended certain trust funds without an approved dedication by rider from the State of New Jersey. There are trust funds that are established for specific purposes and are required to be approved by the DLGS. It was found that the Township has a trust fund for police outside employment, which was never established with the DLGS. Therefore, a resolution was adopted during the November 18<sup>th</sup> meeting and same was forwarded to the DLGS, which shall satisfy that finding. The second finding was in 2019 the Township had appropriated and dispersed \$200,000 to the EMS and that was not in compliance with statute 40:5-2 which stipulates the Township can contribute \$70,000 however, anything above \$70,000 had additional criteria that was required. For the 2020 audit the Township as only appropriated and dispersed the allowable \$70,000 therefore, that finding is now satisfied.

Some of the benches and tables at the parks are falling apart and are not handicapped accessible. All of those tables will be removed and replaced with all ADA complaint tables and benches for the Mansfield Community Park.

## AN ORDINANCE OF THE TOWNSHIP OF MANSFIELD, COUNTY OF BURLINGTON, STATE OF NEW JERSEY AMENDING ORDINANCE 2019-19 AND THE CODE OF THE TOWNSHIP CHAPTER 42 – "SALARIES"

**BE IT ORDAINED** by the Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey that:

## **SECTION 1:**

Ordinance 2019-19 and Chapter 42 of the Code of the Township of Mansfield is hereby amended to revise the Salary Range for the Township Administrator (full time) and to establish Titles and Salary Ranges for positions created, and to delete Titles and Salary Ranges for positions eliminated, in the Township since the adoption of Ordinance 2019-19, as follows:

The Mansfield Township Committee only repeals and replaces those sections of Ordinance 2019-19 expressly amended herein and the balance of Ordinance 2019-19 is expressly saved from repeal.

- A. <u>Repealer</u>. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability</u>. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.

WHEREAS, G & G Landscaping Construction Company Inc. has submitted a proposal dated December 4, 2020 indicating they will perform the services of construction of the 2019 CDBG Mansfield Community Park ADA Compliant Walkway for the proposed amount of \$24,825.50; and

WHEREAS, to satisfy the provisions of N.J.S.A. 19:44A-20.5, concerning eligibility for municipal contracts, Contractor has completed and submitted a Business Entity Disclosure Certification which certifies that G & G Landscaping Construction Inc. has not made any reportable contributions to a political or candidate committee in the Township of Mansfield to Mayor Janice A. DiGiuseppe, Deputy Mayor Frederick Cain, Committeeman Robert J. Higgins, Committeeman Michael H. Magee or Committeeman Rude Ocello in the previous one year, and that the contract will prohibit G&G Landscaping Construction Inc. from making any reportable contributions through the term of the contract, and

WHEREAS, the Chief Financial Officer, Bonnie Grouser, has certified that sufficient funds are available to award said contract; and

# AUTHORIZING EXECUTION OF AMENDMENT TO 2005 CENTEX SETTLEMENT AGREEMENT

**WHEREAS**, Centex Corporation (now Pulte), Mansfield Township and the Mansfield Township Planning Board are parties to a certain 2005 Settlement Agreement (the "Settlement Agreement"); and

**WHEREAS,** the Settlement Agreement resolved litigation between the parties concerning the development of property in the Township identified in the Settlement Agreement and known as Block 41, Lot 2.01 (the "Reed Property") and Block 42, Lot 1 ("the "Carty Property"); and

**WHEREAS**, the Settlement Agreement provided for dedication of the Reed Property to Mansfield Township, which has accomplished and completed; and

**WHEREAS,** the Settlement Agreement further provided for the payment of certain sums to the Township from the sale of each building lot by Centex to assist the Township in providing public sewer to certain areas of the Township; and

**WHEREAS**, the Settlement Agreement further provided for the development of the Carty Property for market rate age restricted homes, with a required set-aside for affordable housing; and

**WHEREAS,** the Township was subsequently named a Defendant in a builders remedy lawsuit requiring the Township to provide affordable housing in the Township; and

**WHEREAS**, as a result of said litigation, the Court established and ordered that the Township's constitutional obligation to provide for its regional share of affordable housing consisted of 379 units (114 units Second Round obligation, 255 units Third Round) and that the Township was entitled to a credit of 97 units of affordable housing already provided in the Villages of Mapleton; and

**WHEREAS,** as required by the builders remedy litigation, the Township prepared a Housing Element and Fair Share Plan (HE/FSP); and

**WHEREAS**, said HE/FSP provided, on page 52 that, the Carty Property was already recognized as "available, suitable, developable and approvable" under applicable COAH regulations, and thus was and is an appropriate affordable housing site; and

**WHEREAS,** the HE/FSP further provided, on page 53, that the Carty property would be developed for affordable housing as a necessary component of the Township's overall affordable housing obligation, and to accommodate said affordable housing, the Property would be rezoned for a density of four units per acre with a 20% set-aside for affordable housing, of which 13% would be available for very-low income housing; and

WHEREAS, the Township's HE/FSP was conditionally approved by Court Order dated February 19, 2020; and

**WHEREAS**, the Court Order further required the Township to satisfy all of the conditions of the Court Order, during the Court-ordered compliance phase, including an agreement with Pulte Homes as set forth in section 2(e) below:

"During the compliance phase, the Township shall provide to the Special Master, and to the Court, a Development Agreement between Mansfield Township and Pulte Homes and/or its successor-in-interest, as well as an inclusionary Zoning Ordinance to address the Pulte Homes component of the Township's overall HE/FSP. The percentage of the proposed affordable housing set-aside should be clarified and revised if necessary in the draft HE/FSP. The draft HE/FSP, the Development Agreement and Zoning Ordinance should specify the correct percentage of affordable units and identify applicable compliance parameters regarding income mix, bedroom mix, thirteen per cent (13%) very low income, affirmative marketing, 30 year income controls, consistent with HUAC Section 5:80 and any other relevant information and standards required to be met."; and

**WHEREAS,** The Township has negotiated an Amendment to the Settlement Agreement (the "Amendment"), said Amendment attached hereto and made a part hereof as Exhibit A; and

WHEREAS, the Amendment provides, *inter alia*, for the aforesaid rezoning of the Carty Property at a gross density of four units per acre with a 20% affordable housing set-aside, and further provides for development of the property in two phases. The first phase of the development will generate a portion of the required number of affordable units to satisfy the Township's current affordable housing obligation in Rounds Two and Three, based on the HE/FSP and the Court Order. The Amendment permits development of market housing in the second phase based on the Township's need to provide the required number of affordable units that the Township may be obligated to provide in the future, including Round Four, which is unknown at this time; and

**WHEREAS**, The Township Committee finds that the negotiation and execution of the Amendment to the Settlement Agreement is in the best interests of the residents and citizens of Mansfield Township for the following reasons:

1. As set forth in the Settlement Agreement, the Carty property was already approved for market rate housing at a density required to generate affordable housing on the site.

- 2. The Carty Property has already been recognized as "available, suitable, developable and approvable" under applicable COAH regulations, and thus was and is an appropriate affordable housing site.
- 3. The Carty property was already designated as an affordable housing site and a part of the Township's Housing Element and Fair Share Plan (HE/FSP) approved by Court Order.
- 4. The density and affordable housing set-aside in the first phase of the development of the Carty Property is directly tied to the Township's constitutional obligation to provide for its regional share of affordable housing in Rounds One and Two, as set forth in the HE/FSP and the Court Order approving same.
- 5. The density and affordable housing set-aside in the first phase of the development of the Carty Property further provides a "buffer" to protect the Township against non-compliance with the HE/FSP and the Court Order approving same, based on other components of the HE/FSP.
- 6. The density and affordable housing set-aside in the phase 2 of the development of the Carty Property is directly tied to the Township's constitutional obligation to provide for its regional share of affordable housing in Round Four and in the future, which at present is unknown.
- 7. The provisions of the Amendment protect the Township against future builders remedy litigation and the need to identify other sites for affordable housing both now and in the future.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Mansfield, County of Burlington, and State of New Jersey, that the Mayor and Clerk are hereby authorized to execute and deliver on behalf of the Township the Amendment to 2005 Centex Settlement Agreement attached hereto and made a part hereof as Exhibit A.

**WHEREAS,** Michael Fitzpatrick (the "Administrator") has served as the Township Administrator of Mansfield Township since July 28, 2014 and currently is employed pursuant to an Employment Agreement To Extend Full-Time Township Administrator, dated September 11, 2017 (the "Employment Agreement"); and

WHEREAS, the Township Committee has reviewed the compensation paid to other Administrators in other municipalities in Burlington County and, further, in recognition of the Administrator's excellent performance in office, the Township Committee finds that it is in the best interest of the citizens of Mansfield Township to extend the term and further amend the provisions of the Administrator's Employment Agreement, as Administrator, as set forth in the Amendment attached hereto as Exhibit A. The Amendment authorizes an annual salary of \$115,000, as

Township Administrator, payable on a bi-weekly basis, effective first pay of 2021, together with such regular raises that shall be provided to all Management/Supervisory personnel in the Township, as well as all benefits afforded to a full-time Township employee, including full health benefits, and vacation, sick time and personal time, all effective as of January 1, 2021.
