**RESOLUTION REVISING THE ESTABLISHED 2018 POLICE RATES OF PAY FOR EXTRA
DUTY RELATIVE TO THE INTER-LOCAL SERVICES AGREEMENT**

WHEREAS, there currently exists a 2018 Police Rate of Pay Table for the Inter-Local Services Agreement; and

WHEREAS, said Table provides that Mansfield Township is being compensated at a reduced rate; and

WHEREAS, it is necessary that said Table be consistent with the January 1, 2022 through December 31, 2024 Collective Bargaining Agreement/Memorandum of Agreement; and

WHEREAS, it is the intent of the Township of Mansfield to revise the Inter-Local Services Agreement Rate Table for more consistency; and

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Mansfield, County of Burlington, and State of New Jersey, that the Police rates for extra duty in the 2018 Inter-Local Services Agreement be modified to reflect that the hourly rate charged to the Northern Burlington County Regional Schools and Manheim New Jersey, both within the Township of Mansfield, be modified to reflect that the hourly rate charged, to said establishments, shall be \$90.00 (ninety dollars) per hour and the hourly rate paid to the assigned officer will be \$60.00 (sixty dollars); and

BE IT FURTHER RESOLVED, by the Township Committee of the Township of Mansfield, County of Burlington, and State of New Jersey, that the Police rates for extra duty in the 2018 Inter-Local Services Agreement be modified to reflect that the hourly rate charged to all outside contractors, municipalities and utilities shall be \$115.00 (one hundred and fifteen dollars) per hour and that the hourly rate paid to the assigned officer will be \$80.00 (eighty dollars) per hour; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the charge for the police car will be \$90.00 (ninety dollars) per day.
