**RESOLUTION AWARDING CONTRACT TO EAST COAST EMERGENCY LIGHTING, INC.
FOR THE PURCHASE AND INSTALLATION OF THE EMERGENCY LIGHTING PACKAGE
FOR THE 2022 CUSTOM TAHOE FOR THE FRANKLIN FIRE COMPANY #1**

WHEREAS, the Township of Mansfield is desirous to purchase and install the emergency lighting package for the 2022 Custom Tahoe to be used by Franklin Fire Company #1; and

WHEREAS, the adopted Capital Ordinance 2021-9 contemplated this purchase; and

WHEREAS, the State of New Jersey Division of Purchase and Property, Cooperative Purchase Program, has authorized vendors that can provide these services, materials, supplies or equipment under a “state contract” for eligible items pursuant to N.J.S.A. 40A: 11-12; and

WHEREAS, said purchase is authorized through State Contract Number #17-FLEET-00768; and

WHEREAS, the Chief Financial Officer, Bonnie Grouser, has determined that sufficient funds are available through issuance of said Capital Ordinance adopted by the Township of Mansfield to finance the same; and

WHEREAS, the vehicles and equipment packages are to be titled to the Township of Mansfield.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey that:

1. The Township Committee hereby awards a Contract to East Coast Emergency Lighting, Inc. in accordance with Franklin Fire Company #1’s specifications and their proposal in the amount of \$17,048.57.
2. The Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey, does hereby authorize the Mayor and Township Clerk to execute on behalf of the Township any and all documentation necessary for said purchase.
3. The vehicles and equipment packages are to be titled to the Township of Mansfield.
