**RESOLUTION AWARDING CONTRACT TO SHERWIN WILLIAMS FOR THE
ACQUISITION OF A SHERWIN WILLIAMS LINE STRIPER FOR THE MANSFIELD
TOWNSHIP PUBLIC WORKS DEPARTMENT**

WHEREAS, the Township of Mansfield is desirous to acquire a Sherwin Williams Line Stripper to be used by the Mansfield Township Public Works Department; and

WHEREAS, said equipment is being purchased with the proceeds generated through an auction that took place through GovDeals; and

WHEREAS, said purchase is being made through the Educational Services Commission of New Jersey (ESCNJ, CO-OP) New Jersey State Approved Cooperative Pricing System #65MCESCCPS/Grounds Equipment Bid #ESCNJ 19/20/-14; and

WHEREAS, the Chief Financial Officer, Bonnie Grouser, has determined that there are sufficient funds for said acquisition; and

WHEREAS, the equipment is to be titled to the Township of Mansfield.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey that:

1. The Township Committee hereby awards a Contract to Sherwin Williams, 1623 Route 38, Lumberton, NJ 08048 in accordance with the Mansfield Township's Public Works Department's specification and their proposal in the amount of \$8,441.99.

2. The Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey, does hereby authorize the Mayor and Township Clerk to execute any and all documents necessary for said purchase.

3. The equipment is to be titled to the Township of Mansfield.
