**MEMORIALIZING RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO
PURCHASE ONE 2022 FORD F-550 DRW (F5H) XL 4WD REG CAB DUMP TRUCK FROM
BEYER FORD PURSUANT TO ESCNJ CO-OP #65MCECCPS – ESCNJ 20/21-55**

WHEREAS, the Township of Mansfield, Burlington County, is a party to a cooperative purchasing agreement with the Educational Services Commission of New Jersey (ESCNJ), a cooperative purchasing program organized pursuant to N.J.S.A. 40A:11-10 and N.J.A.C. 5:34-7.11; and

WHEREAS, the Local Public Contracts Law authorizes a municipality to purchase goods and services through duly-formed cooperative purchasing system without advertising for bids; and

WHEREAS, the procurement of goods and services through a cooperative purchasing program is considered to be a fair and open process under the New Jersey Pay-To-Play Law N.J.S.A. 19:44A-20.4 et seq; and

WHEREAS, the Township of Mansfield, Burlington County, desires to purchase One 2022 Ford F-550 DRW (F5H) XL 4WD Reg Cab Dump Truck from Beyer Ford pursuant to ESCNJ CO-OP #65MCECCPS – ESCNJ 20/21-55; and

WHEREAS, Beyer Ford has submitted a proposal dated June 9, 2021 indicating they will provide the 2022 Ford F-550 DRW (F5H) XL 4WD Reg Cab Dump Truck for the proposed amount of \$47,488.48; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey that:

1. The Township Committee hereby awards a contract for the purchase of One 2022 Ford F-550 DRW (F5H) XL 4WD Reg Cab Dump Truck in accordance with the specifications described in the proposal, by and between Mansfield Township, Burlington County and Beyer Ford, 170 Ridgedale Avenue, Morristown, New Jersey 07960, pursuant to the terms and conditions of the ESCNJ CO-OP #65MCECCPS – ESCNJ 20/21-55, be and is hereby approved and authorized. Said contract is being awarded retroactively to June 16, 2021.
2. Funds for this purchase have been authorized against Capital Ordinance 2021-9, as approved by the Township Committee at the Regular Meeting that was held on May 19, 2021, in the amount of \$1,980,600.00.

BE IT FURTHER RESOLVED that the Mayor and Township Clerk, as necessary, are hereby authorized to execute said contract with Beyer Ford; and
