**RESOLUTION MEMORIALIZING AND ACCEPTING QUOTE FROM CNS CLEANING COMPANY  
FOR ADDITIONAL JANITORIAL CLEANING SERVICES WITHIN THE MANSFIELD TOWNSHIP  
MUNICIPAL COMPLEX**

**WHEREAS**, CNS Cleaning Company has provided general janitorial services for the Mansfield Township Municipal Building, the Police Station, The Training Center, Columbus Park and Georgetown Park since February 1, 2020; and

**WHEREAS**, the Township Committee is desirous of increasing the amount of cleaning to be done in the Municipal Building by adding the cleaning of the second floor restrooms and stairwell monthly; and

**WHEREAS**, a quote was received from CNS Cleaning Company in the amount of \$50.00 per month, bringing the total overall monthly price to \$1,135.00 per month; and

**WHEREAS**, CNS Cleaning Company has agreed to perform said additional janitorial services as scheduled, commencing February 1, 2022; and

**WHEREAS**, the Chief Financial Officer has certified that funds are available in that amount; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Mansfield, County of Burlington, and State of New Jersey that:

1. The Township Committee hereby amends the original Contract award to CNS Cleaning Company, for additional janitorial services at the Mansfield Township Municipal Building, by adding the second floor restrooms and stairwell, in the additional amount not to exceed \$50.00 per month, to be combined with the contract which began on February 1, 2020 and runs through January 31, 2023; and
2. This award is made available through the following account: 01-201-26-310-124
3. The Township Administrator and/or Township Purchasing Agent, as necessary, are hereby authorized to execute an amended Contract and any related documents necessary to effectuate this award in a form substantially the same as that included in the specifications.
