**RESOLUTION AUTHORIZING AND MEMORIALIZING THE CONTINUED SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF SPRINGFIELD AND THE TOWNSHIP OF MANSFIELD FOR MUNICIPAL COURT FACILITIES AND PERSONNEL EFFECTIVE APRIL 1, 2022**

**WHEREAS**, Mansfield Township and Springfield Township entered into a shared services agreement for their respective Municipal Courts in 2011, including the most recent Shared Services Agreement dated April 1, 2017; and

**WHEREAS**, both Mansfield Township and Springfield Township, adjacent municipalities, desire to continue to save costs and provide efficient services to their respective citizens; and

**WHEREAS**, both Mansfield Township and Springfield Township feel it is beneficial to participate engage in a shared services within the Court System; and

**WHEREAS**, a renewal Shared Service Agreement (“Agreement”, copy attached hereto) has been prepared and both Mansfield Township and Springfield Township have consented to all the terms and conditions as set forth therein, subject to formal execution of same; and

**WHEREAS**, Mansfield Township shall provide full and complete Municipal Court facilities and services as may be required by the Administrative Office of the Courts and/or the Assignment Judge of Burlington County; and

**WHEREAS**, said term of the renewal Shared Services Agreement will be for a five (5) year period, beginning April 1, 2022 and terminate on March 31, 2027;

**NOW, THEREFORE, BE IT RESOLVED** that the continued combining of the court system will be subject to the formal execution of said Agreement by the Mayor and Municipal Clerk for both Townships and the final approval by the Administrative Office Of the Courts and the Assignment Judge of Burlington County; and

**BE IT RESOLVED** that the Mayor and Municipal Clerk for the Township of Mansfield, County of Burlington and state of New Jersey are hereby authorized to execute the renewal Shared Services Agreement between the Township of Mansfield and the Township of Springfield.
