**RESOLUTION MEMORIALIZING AN AWARD OF A CONTRACT TO PURCHASE THREE (3) STRYKER POWER LOAD SYSTEMS AND TWO (2) STRYKER POWER PRO STRETCHERS PURSUANT TO THE NEW JERSEY COOPERATIVE PURCHASING ALLIANCE #CK04**

**WHEREAS**, the Township of Mansfield, Burlington County, is a party to a cooperative purchasing agreement with the New Jersey Cooperative Purchasing Alliance #CK04, a cooperative purchasing program organized pursuant to N.J.S.A. 40A:11-10 and N.J.A.C. 5:34-7.11; and

**WHEREAS**, the Local Public Contracts Law authorizes a municipality to purchase goods and services through duly-formed cooperative purchasing system without advertising for bids; and

**WHEREAS**, the procurement of goods and services through a cooperative purchasing program is considered to be a fair and open process under the New Jersey Pay-To-Play Law N.J.S.A. 19:44A-20.4 et seq; and

**WHEREAS**, the Township of Mansfield, Burlington County, desires to purchase three (3) Stryker Power Load Systems and two (2) Stryker Power Pro Stretchers from Stryker Medical pursuant to the New Jersey Cooperative Purchasing Alliance #CK04, Bergen County Bid #: 22-14 for First Responder Emergency Medical Supplies & Equipment; and

**WHEREAS**, Stryker Medical has submitted a proposal dated September 1st, 2022 indicating they will provide the three (3) Stryker Power Load Systems for the proposed amount of \$77,927.40 and two (2) Stryker Power Pro Stretchers for the proposed amount of \$47,624.40; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey that:

1. The Township Committee hereby awards a contract for the purchase of three (3) Stryker Power Load Systems and two (2) Stryker Power Pro Stretchers in accordance with the specifications described in the proposals, by and between Mansfield Township, Burlington County and Stryker Medical, PO BOX 93308, Chicago, IL 60673, pursuant to the terms and conditions of the New Jersey Cooperative Purchasing Alliance #CK04, Bergen County Bid #: 22-14 for First Responder Emergency Medical Supplies & Equipment, be and is hereby approved and authorized. Said contract is being awarded retroactively to September 8<sup>th</sup>, 2022.
2. Funds for this purchase have been authorized against Capital Ordinance 2022-10, as approved by the Township Committee at the Regular Meeting that was held on August 17th, 2022, in the amount of \$3,382,774.00

**BE IT FURTHER RESOLVED** that the Mayor and Township Clerk, as necessary, are hereby authorized to execute said contract with Stryker Medical; and
