**RESOLUTION MEMORIALIZING AN AWARD OF A CONTRACT FOR THE PURCHASE AND
INSTALLATION OF POURED IN PLACE RUBBER SURFACING FOR MANSFIELD
COMMUNITY PARK PLAYGROUND FROM BEN SHAFFER RECREATION, INC. PURSUANT
TO ESCNJ CO-OP #65MCESCCPS – ESCNJ 20/21-02**

WHEREAS, the Township of Mansfield, Burlington County, is a party to a cooperative purchasing agreement with the Educational Services Commission of New Jersey (ESCNJ), a cooperative purchasing program organized pursuant to N.J.S.A. 40A:11-10 and N.J.A.C. 5:34-7.11; and

WHEREAS, the Local Public Contracts Law authorizes a municipality to purchase goods and services through duly-formed cooperative purchasing system without advertising for bids; and

WHEREAS, the procurement of goods and services through a cooperative purchasing program is considered to be a fair and open process under the New Jersey Pay-To-Play Law N.J.S.A. 19:44A-20.4 et seq; and

WHEREAS, the Township of Mansfield, Burlington County, desires to purchase for installation poured in place rubber surfacing for Mansfield Community Park Playground from Ben Shaffer Recreation, Inc. pursuant to ESCNJ CO-OP #65MCESCCPS – ESCNJ 20/21-02; and

WHEREAS, Ben Shaffer Recreation, Inc. has submitted a proposal dated April 25th, 2022 indicating they will provide and install the poured in place rubber surfacing for Mansfield Community Park Playground for the proposed amount of \$214,138.20; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey that:

1. The Township Committee hereby awards a contract for the purchase and installation of poured in place rubber surfacing for Mansfield Community Park Playground in accordance with the specifications described in the proposal, by and between Mansfield Township, Burlington County and Ben Shaffer Recreation, Inc., PO BOX 844, Lake Hopatcong, New Jersey 07849, pursuant to the terms and conditions of the ESCNJ CO-OP #65MCESCCPS – ESCNJ 20/21-02, be and is hereby approved and authorized. Said contract is being awarded retroactively to September 8th, 2022.
2. Funds for this purchase have been authorized against Capital Ordinance 2022-10, as approved by the Township Committee at the Regular Meeting that was held on August 17th, 2022, in the amount of \$3,382,774.00

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon adoption hereof.
