**A RESOLUTION TO APPROVE RAFFLE LICENSE RA 2023-15 FOR THE
NORTHERN BURLINGTON STAGEHOUNDS
(Legalized Games of Chance Control Commission Registration #282-5-42940)**

WHEREAS, the Northern Burlington Stagehounds submitted an application on December 12, 2023 for an on-premises draw raffle awarding cash to be held on February 2, 2024 at Northern Burlington County Regional High School; and

WHEREAS, one copy of the application will be filed with the Mansfield Township police department; and

WHEREAS, N.J.A.C. 13:47-4.1 requires seven (7) days to elapse before the Governing Body makes its findings and determinations; and

WHEREAS, the required waiting period was satisfied on December 19, 2023; and

WHEREAS, the Northern Burlington Stagehounds, in accordance with N.J.A.C. 13:47-3 et. seq, will submit the required fee to the Legalized Games of Chance Control Commission in the case the cash prize awarded exceeds \$400; and

WHEREAS, the Northern Burlington Stagehounds has submitted the \$20 required fee to the Township of Mansfield; and

WHEREAS, the Northern Burlington Stagehounds has submitted a valid Legalized Games of Chance Control Commission (LGCCC) registration certificate and number.

NOW, THEREFORE, BE IT RESOLVED by the Committee of the Township of Mansfield in the County of Burlington, State of New Jersey that Raffle License RA 2023-14 for the Northern Burlington Stagehounds to conduct an on-premises draw raffle awarding cash on February 2, 2024 be approved effective January 17, 2024, following the expiration of the seven (7) day waiting period and submission of the required Governing Body's Findings and Determinations to the LGCCC according to N.J.A.C. 13:47-1.1; and

BE IT FURTHER RESOLVED that the Municipal Clerk forward the required Findings and Determinations to the LGCCC according to N.J.A.C. 13:47-1.1.


