COORDINATOR'S REPORT

- Civic Club Bridge - Is temporarily fixed. Thank you to the Township Committee for their swift action to get it repaired.
- Repairs to the Mansfield Community Park basketball courts and the Country Walk tennis courts are almost complete. The Township Committee is voting on an ordinance in the September meeting to allocate bond funds to complete the Mapleton Tennis and Basketball courts. Both tennis courts will have pickleball courts also included,
- Mansfield Community Park horseshoe pits are in disrepair. Suggestion is to replace them with gaga pits. Paul Narwid to coordinate with Public Works to see if the area can support a gaga pit.
- With the Babe Ruth field now available for 50/70 use, a temporary outfield fence needs to be purchased. The cost is \$1931 to purchase.
- Access control system for both the Mansfield Community Park concession stand, and the indoor facility need to be replaced. A cloud based solution was quoted at \$3325. Paul Narwid will arrange installation.

CHAIRPERSON REPORT

- Asked on the status of the access cards for the indoor facility. Access system is not working at this time and the cards will be disabled.
- Asked about the retrofitting of the walls in the Mansfield Community Park restrooms with metal to prevent vandalism. Paul Narwid in discussions with Public Works will most likely use plywood instead of metal, as it is cost prohibitive.
