**RESOLUTION MEMORIALIZING AWARD OF CONTRACT FOR  
LAWN MAINTENANCE SERVICES AT THE COUNTRY WALK PARK**

**WHEREAS**, in accordance with the State of New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. (the "LPCL"), the Temporary Purchasing Agent Township of Mansfield (the "Township") previously advertised and solicited bids for a contract for lawn maintenance services at the Country Walk Park (the "Contract"); and

**WHEREAS**, the LPCL authorizes the Township, through its Temporary Purchasing Agent, to award the Contract to the lowest qualified bidder; and

**WHEREAS**, Rahn Landscaping, LLC ("Rahn") was the lowest qualified bidder for the Contract; and

**WHEREAS**, the total bid submitted by Rahn is sixteen thousand three hundred and two dollars and zero cents (\$16,302.00).

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey, that, as recommended by the Temporary Purchasing Agent, the bid submitted by Rahn Landscaping, LLC is hereby accepted; and

**BE IT FURTHER RESOLVED** that the Township, as recommended by the Temporary Purchasing Agent, hereby memorializes the award of the "Contract for Lawn Maintenance Services at the Country Walk Park," to Rahn Landscaping, LLC, a copy of which is annexed hereto as "Exhibit A; and

**BE IT FURTHER RESOLVED** that the Township Mayor and Township Clerk are hereby authorized to execute the Contract and all documents required to effectuate the award of such Contract; and

**BE IT FURTHER RESOLVED** that this award is made available through the following account: 01 201 28 375 103

**BE IT FURTHER RESOLVED** that an original, fully-executed copy of the Contract shall be delivered to the Township Administrator; and

**BE IT FURTHER RESOLVED** that the Township Clerk shall publish a notice of the award of the Contract to Rahn in the official newspaper of the Township as required by the LPCL.
