**RESOLUTION AUTHORIZING THE AWARD OF A  
“REQUIRED DISCLOSURE” CONTRACT FOR THE PURCHASE OF A  
FERRI TM46 3POINT MOUNTED MOWER WITH HAMMERS FLAIL ARM**

**WHEREAS**, the Township of Mansfield has the need to acquire a Ferri TM46 3Point Mounted Mower with Hammers Flail Arm; and

**WHEREAS**, as permitted by the New Jersey Local Public Contracts Law, N.J.S.A. 40A: 11-3. since the anticipated amount of the contract did not exceed the statutory maximum of \$44,000, the Township Qualified Purchasing Agent authorized the award of a contract for the purchase of one Ferri TM46 3Point Mounted Mower with Hammers Flail Arm to Central Jersey Equipment (“Vendor”) as a “Required Disclosure” contract based on proposals pursuant to the aforesaid statutory provisions; and

**WHEREAS**, the total amount of the Contract will exceed the \$17,500 statutory maximum in the aggregate set forth in N.J.S.A. 19:44A-20.5, concerning eligibility for municipal contracts; and

**WHEREAS**, the anticipated term of this contract is one (1) year from July 1, 2021 but in no event shall the total amount of the contract amount exceed the bid threshold of \$44,000 pursuant to N.J.A.C. 5:34-8.1(b); and

**WHEREAS**, Central Jersey Equipment has submitted a proposal dated June 10, 2021 indicating they will provide the Ferri TM46 3Point Mounted Mower with Hammers Flail Arm for the proposed amount of \$23,419.00; and

**WHEREAS**, to satisfy the provisions of N.J.S.A. 19:44A-20.5, concerning eligibility for municipal contracts, Vendor has completed and submitted a Business Entity Disclosure Certification which certifies that Central Jersey Equipment has not made any reportable contributions to a political or candidate committee in the Township of Mansfield to the following elected officials; Mayor Michael H. Magee, Deputy Mayor Robert Tallon, Committeeman Robert J. Higgins, Committeeman Rudy Ocello or Committeeman Daniel Golenda in the previous one year, and that the contract will prohibit Central Jersey Equipment from making any reportable contributions through the term of the contract, and

**WHEREAS**, the Chief Financial Officer, Bonnie Grouser, has certified that sufficient funds are available to award said contract; and

**NOW, THEREFORE, BE IT RESOLVED** that the Governing Body of the Township of Mansfield authorizes the Qualified Purchasing Agent to enter into a contract with Central Jersey Equipment as described herein; and,

**BE IT FURTHER RESOLVED** that the Business Entity Disclosure Certification and the Determination of Value be placed on file with this Resolution, and

**BE IT FURTHER RESOLVED** that the Mayor and Township Clerk, as necessary, are hereby authorized to execute said contract with Central Jersey Equipment; and

**BE IT FURTHER RESOLVED** Notice of said action shall be published in the Burlington County Times and the Trenton Times as required by law.
