**RESOLUTION ACCEPTING AWARD NUMBER 21-BWC-250 DATED JUNE 30, 2021 TO THE TOWNSHIP OF MANSFIELD, BURLINGTON COUNTY, FROM THE STATE SFY21 BODY-WORN CAMERA GRANT PROGRAM IN THE AMOUNT OF \$40,760.00 WITH NO REQUIRED IN-KIND OR CASH MATCH FOR THE AWARD PERIOD JANUARY 1, 2021 TO DECEMBER 31, 2025.**
