**RESOLUTION AUTHORIZING AN AWARD OF AN EMERGENCY CONTRACT PURSUANT
TO N.J.S.A.40A:11-6 FOR THE EMERGENCY REPLACEMENT OF THE STORM CULVERT
PIPE WITHIN MILL LANE**

WHEREAS, an emergency has arisen with respect to the replacement of the storm culvert pipe within Mill Lane; and

WHEREAS, the Township Superintendent, upon recommendation from Remington & Vernick Engineers, has determined it was an emergency affecting the public health, safety and welfare and needed to be repaired; and

WHEREAS, an emergency contract pursuant to N.J.S.A.40A:11-6 may be awarded without advertisement for bids or bidding in that an emergency affecting the health and public safety requires the immediate performance of the services; and

WHEREAS, the Township Engineer has received a proposal and has recommended the award of the Emergency Replacement of the Storm Culvert Pipe within Mill Lane to R. Moslowski Excavating, Inc., 3 Meirs Road, Cream Ridge, New Jersey, 08514 in the amount of \$126,126.00; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey that:

1. An emergency exists with respect to the immediate need to replace the storm culvert pipe within Mill Lane, which emergency required the immediate procurement of services in order to protect public health, safety and welfare.
2. The Township Committee hereby awards a contract to R. Moslowski Excavating, Inc., 3 Meirs Road, Cream Ridge, New Jersey, 08514 in accordance with the Township Engineer's specifications and their proposal in the amount of \$126,126.
3. The Township Committee of the Township of Mansfield, County of Burlington, State of New Jersey, does hereby authorized the Mayor and Committee to execute any and all documentation necessary for said services.

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon adoption hereof.
